ADMINISTRATIVE ORDER 2011-18

MOTIONS AND SCHEDULING FOR TAX OBJECTION CASES

EFFFECTIVE immediately, and, unless otherwise provided by Circuit Court Rule 10-6 and 10-8, and other pertinent rules, all County Division real estate tax objection case motions and the scheduling of same shall be as follows:

- County Division Tax Motions are to be submitted in the Office of the Presiding Judge, Room 1701, in the individual Judges' Calendar mailbox slot.
- 2. A proposed Order shall accompany the motion.
- 3. A date shall be selected by the lawyer or party in accordance with the attached motion call schedule for each individual judge.
- Sufficient courtesy copies shall be provided.
- 5. If the Judge grants the date, the Judge will execute same and have the his or her clerk enter the order, or if the judge has no clerk, then he or she shall give it to the Office of the Presiding Judges' Staff who shall be directed to submit to a clerk for entry.
- 6. Courtesy copies shall be left in the "out" box bin in the 1701 antechamber, if so provided by the party or lawyer.
- The Clerk's Office shall notify parties and/or attorneys of this new directive downstairs in room 1202, if the attorney is unaware of this new procedure.
