AMENDED MENTAL HEALTH CALL

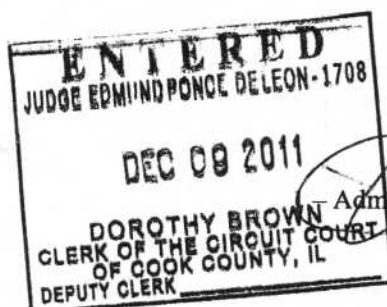
The Illinois Department of Human Services has officially informed this Court that the Tinley Park Mental Health Center premises used for mental health hearings shall close and will no longer be available for hearings beginning December 31, 2011. Speculation that parts or all of the hospital premises may remain open, for an interim period, creates instability for the Court.

ACCORDINGLY, EFFECTIVE **January 2<sup>nd</sup>, 2012**, all prior mental health hearing locations are amended as previously ordered and shall be heard as follows:
