Courtesy copies of motions should be provided to the Court via email at catherine.schneider@cookcountyil.gov no less than three business days prior to motion hearing. The subject of the email must contain the name of the party filing the motion, the case number and the date and time of the motion call. Discovery motions must include proof of compliance with Illinois Supreme Court Rule 201(k).

Trials (other than Mental Health Trials), Evidentiary Hearings, Pre-Trial Conferences and Settlement Conferences will be conducted "in person" in Courtroom 1706. Parties may request by motion filed in advance to appear remotely. Orders setting such matters must designate whether the matter will be held in person or remotely, or in a hybrid manner.

Draft Orders: All draft orders reflecting the Court's rulings must be provided promptly to the Court for entry following the appearance before the Court, but no later than the close of business that day.

Agreed Orders: The Court encourages the parties to reach agreements outside of court.
